# Coalition Work Recognized by the Montana Medical Association

A recipient cohort of the 2025 MMA Award of Merit

**Helena, MT, October 2, 2025** – The Montana Medical Association (MMA) recognized Sarah Morgan, M.D., of Bozeman, Justin Cole, Esq of Missoula and Jean Branscum, CEO of Helena as recipients of *The Award of Merit* during the 147<sup>th</sup> MMA Annual Meeting on September 12<sup>th</sup>. Recipients were honored for their leadership within a coalition organized to safeguard access to healthcare in rural communities, preserve specialty and high-risk medical services, and stabilize the medical liability insurance landscape in Montana.

"Their work unified coalition members around a balanced approach—ensuring fair patient compensation for non-economic damages while protecting access to care and controlling healthcare costs," stated MMA President Ernest Gray, MD.

The risk of medical malpractice litigation remains one of the most significant challenges facing physicians, and the growing trend of high-value liability verdicts and settlements across the nation directly influences where and how physicians choose to practice. To safeguard the availability and affordability of health care, interested stakeholders came together around the common interest to maintain and modernize Montana's policy. Ultimately, the Medical Liability Coalition was successful in passing legislation which has created enduring benefits for Montana's healthcare system, including improved access to care statewide, greater stability in the medical liability environment, and enhanced physician recruitment, retention, and institutional viability.

The Montana Medical Association led the effort to form the coalition and was represented by three coalition members:

- **Sarah Morgan, M.D.** Immediate Past President of the MMA Board of Trustees and emergency medicine specialist at Bozeman Health Deaconess Regional Medical Center. Dr. Morgan played a key role in representing physicians' perspectives in shaping policy.
- **Justin Cole, ESQ** MMA legal counsel and lead Medical Liability Coalition member, Mr. Cole is a managing partner at Garlington | Lohn | Robinson in Missoula. He brought extensive expertise in health law, guiding strategies and legislative priorities.
